**NOTES:**

1. Every candidate for Election to the Managing Committee shall be a member of the Gymkhana under Rule 6(a), 6(b), 6(c) for a continuous period of not less than 10 years and entitled to vote at the AGM and shall be proposed and seconded by a member entitled to vote at the AGM. (However, a member's child who is converted to regular membership under Rule 18A shall be eligible for election to the Managing Committee, provided he/she has been a member of the Gymkhana under Rule 6(a), 6(b) and/or 6(c) for a continuous period of not less than 7 years.

A person who has been elected as President for THREE terms of 2 years each, whether consecutive or otherwise shall not be eligible for re-election and/or co-option as a President or Vice-President or a Member to the Managing Committee/Department Secretary at any time thereafter.

A person who has been elected, nominated or co-opted as a Member of the Managing Committee for THREE consecutive terms of 2 years each, shall not be eligible for the election, nomination and/or co-option as a Member to the Managing Committee for a fourth consecutive term of two years including department secretaries.

2. Deposit for the post of President is Rs. 1,000/-, Deposit for the post of Managing Committee Member is Rs. 250/-
3. The Candidates who withdraw their nominations before 7 pm on 18/09/2026 shall lose 50% of their deposit. The Candidates who withdraw their nominations subsequently shall lose the entire deposit.
4. The Candidates who poll less than 10% of the votes, polled shall lose their deposits.
5. Ballot paper/E-voting shall be given to a voter only on production of valid RFID SMART CARD / valid Temporary identity card / valid identity card along with original valid Government photo identity card on voting day to be eligible to vote.

Bonafide members who do not have valid Membership Identity card can apply for a Temporary card four days prior to the elections. Temporary cards will be issued on production of valid government identification only.
